“Generosity and Altruism continue to be the American Way Even at a Very Young Age”

In a national poll conducted by PARADE, in which 1008 respondents were surveyed, 94% believed that it is “important to be personally involved in supporting a cause we believe in” in our communities while 78% believe that they are more involved in making a difference than their parents.

Additionally, ninety percent of parents polled were particularly proud in their efforts to teach their children the importance of activism. These lessons are being taught in various ways including: leading by example (64%); talking to their kids about important issues and causes (51%); discussing their own charitable contributions or efforts

(35%); taking them to meetings or when they volunteer (3.2%) urging them to follow role models who are working for positive change (31%); and encouraging them to donate their own money to causes (25%).

In a time where families are heavily involved in a wide variety of activities, this is an invaluable lesson to be learned. These children are the future of our communities and by emphasizing the importance of engaging in community service, volunteer activities and supporting those less fortunate, we will create a better future for our children and those around them. Just take a look back at one of Care For Other’s youngest donors, Isaac, who at the age of 5 sold lemonade and cookies, which raised \$28 in support of Care

For Others! This is truly our next generation taking an active role in supporting those who need a helping hand!

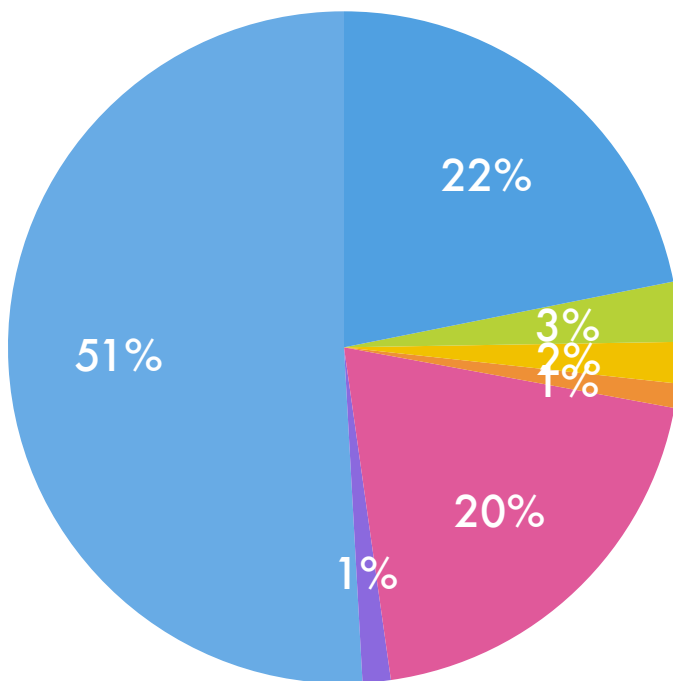

2009 Helping Hands Grants

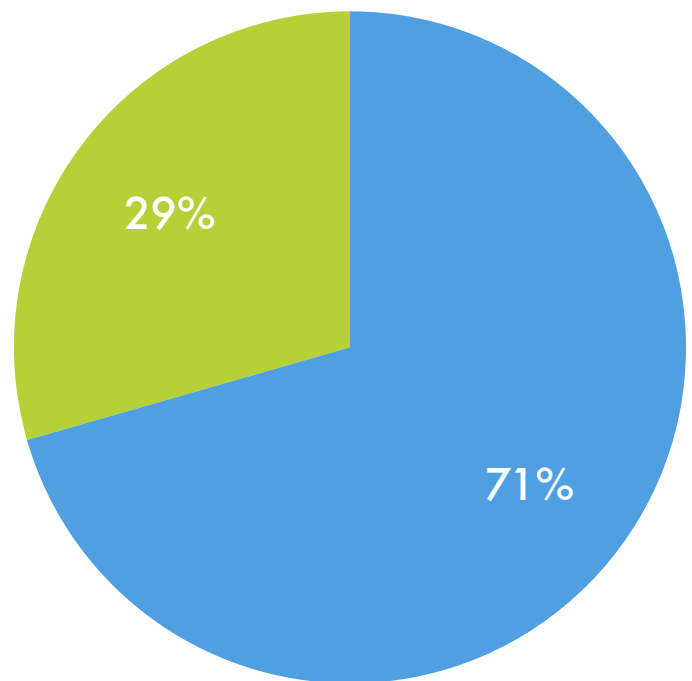
In 2009, Care For Others received 281 applications for Helping Hands Grants. Out of those 281, 83 did not follow through with the application process, 164 did not meet CFO's eligibility requirements, and 34 successfully received a much needed helping hand. During the past year, we have experienced a declining economy along with an increase in the number of job losses, putting many applicants beyond the scope of our reach with a continued need for monetary assistance. In 2010, we are hopeful for an improved economy and look forward to helping more people in their *short term* financial bind, while keeping them self sufficient and free from poverty stricken circumstances.
